

Bullying Prevention Specialist Training

COURSE DESCRIPTION:

School counselors recognize the need for all students to attend school in a safe, orderly and caring environment. To promote this type of environment, comprehensive school counseling programs should include anti-bullying/harassment and violence-prevention programs along with comprehensive conflict- resolution programs to foster a positive school climate. Prevention programs increase the opportunity for improved academic achievement, appropriate behavior, positive relationships, successful resolution of conflicts, safe school climate and increased attendance. Participating in prevention activities empowers and encourages students to take responsibility for their behavior and for the climate of their school and community.

School counselors play a critical role in the development of policies supporting a safe school environment, and they provide leadership to the school by assisting in the design and implementation of schoolwide anti-bullying/harassment, violence prevention and conflict-resolution activities and programs. Learn how to create a comprehensive bullying prevention program in your school that promotes a safe and positive learning environment for your students.
