NATIONAL MEMBERSHIP CATEGORIES

Professional Membership - \$129

School counseling professionals who hold a master's degree or higher in school counseling or the substantial equivalent and are employed as school counselors; supervisors of school counselors or school counseling at the school, district or state level; or professors of counseling in a graduate program that prepares school counselors are eligible for Professional membership. This is a voting membership type.

Retired Membership - \$69

Professional members in retirement are eligible for retired membership. This is a voting membership type. It does not include member liability insurance.

Student Membership - \$69

Students enrolled in a master's-level program that prepares school counselors are eligible for student membership. (Doctoral students who meet the requirements for Professional membership may join in that category; otherwise, see Affiliate category.) This is a nonvoting membership type.

Affiliate Membership - \$129

Individuals interested in school counseling, who are not eligible for any other type of membership, may become affiliate members. This is a nonvoting membership type.

MEMBERSHIP DUES OPTIONS

ASCA offers three options for paying your membership dues.

- **1. Yearly payments:** This payment option is available to all member types. Pay your dues in full up front, and receive a renewal notice each year.
- 2. Auto renewal of yearly payments: (professionals only; you must pay with credit card) Professional members paying by credit card may choose to have their annual dues automatically renewed each year. You will receive an e-mail reminder approximately 30 days before expiration letting you know that ASCA will be charging your credit card next month for your annual dues payment. Check the box on the reverse side for automatic yearly renewal.
- **3. Monthly payments:** (professionals only; you must pay with credit card) Professional members may pay their dues in monthly installments of \$12.95. These payments will be charged to your credit card each month unless you choose to cancel your membership.

State/Territory Membership Fees (professionals only)

If you reside in one of the following states/territories, you can join ASCA and your state/territory association at the same time on this form. If you're only joining your state/territory association, you must do it through the individual state/territory association instead. (All state/territory dues amounts are for professional membership.
