MENTAL HEALTH SERVICE PROFESSIONAL DEMONSTRATION GRANT

ASCA wrote a letter of support for the Mental Health Service Professional Demonstration Grant for the University of New York at Buffalo for a project titled "Empowering Culturally and Linguistically Diverse Communities Together (ENACT) and Florida Atlantic University's application titled Making WAVES (Wellness Advocates Valuing Educators and Students) – A Mental Health Service Professional Grant.

FEDERAL ADVOCACY

ASCA, along with the National Association of School Psychologists, the School Social Work Association of America and the American Psychological Association, <u>authored a letter</u> to the House Appropriators Committee requesting S250 million to be divided between the Mental Health Service Professional Demonstration Grant Program and the School-Based Mental Health Services Grant Program. Together, these grants support efforts to train, recruit and retain school mental health professionals to increase the pipeline of qualified school mental health professionals and expand access to comprehensive school mental health services.

ASCA <u>signed on to a letter</u> by the Social and Emotional Learning Coalition to the Labor, Health and Human Services, Education and Related Agencies Appropriations Subcommittee to encourage funding of the Education Innovation and Research program at \$269,000,000, consistent with the president's FY25 budget request, including providing continued support for social and emotional learning grants.

ASCA, along with 180+ national, state and local organizations, <u>signed on to a letter</u> to urge U.S. House and Senate Appropriations Committees to provide S1.6 billion in fiscal year 2025 for the Student Support and Academic Enrichment grant program, known as Title IV-A, authorized under the Every Student Succeeds Act.

<u>APPLICATION FOR FUNDING: FAFSA STUDENT SUPPORT</u> <u>STRATEGY</u>

A S50 million program is part of the FAFSA Student Support Strategy to help districts, states, nonprofits and other public and private organizations with efforts to boost FAFSA completion. The program will be implemented by ECMC to support organizations with demonstrated experience in expanding college access and enrollment. The funding will be prioritized for organizations currently working with schools and districts and those that have deep ties with students and families that have the reach and capacity to help decrease barriers and increase FAFSA submissions. It will also facilitate FAFSA submission clinics, including through partnerships with schools and districts, and provide transportation support as needed.

COLLABORATION

On May 14, Jill Cook and Amanda Fitzgerald participated in a webinar commemorating the 70th anniversary of Brown v. Board of Education – 70 Years after Brown v. Board of Education: The Legacy, the Work Done, and the Work. The attorney general, secretary of education, assistant attorney general for Civil Rights, president of the NAACP Legal Defense Fund, cofounder and chief legal counsel of Brown's Promise spoke.
